Monitoring and Reporting Mechanism

1. **Project documentation**: Project reporting and monitoring occurs monthly for key parameters, while a more detailed list is reviewed quarterly and annually. Comprehensive updates are presented to the CSR Committee and the Board on a quarterly basis. Additionally, we receive a narrative report each quarter highlighting the project's progress.
2. **Financial tracking**: Quarterly fund utilization certificates(unaudited) are verified by the CSR team and are reported to the board annually (NGO submits audited utilization certificates annually)
